**CHIEF JUDGE OF THE SALISH KOOTENAI TRIBAL COURT  
ADMINISTRATIVE ORDER  
23-03**

The Confederated Salish and Kootenai Tribal Court issues this Administrative Order to address the Bail Schedule.

On September 28, 2023, the Chief Judge issued an updated Bail Schedule. Based on issues brought to the Chief Judge's attention, the Chief Judge has reconsidered the updated Bond Schedule as follows.

A Bail Bond Committee shall convene comprised of Ann Miller of Tribal Defender's Office, Maylinn Smith of Tribal Prosecutor's Office, Judge David Morigeau from the Tribal Court, and Louie Fiddler from Tribal Law Enforcement. This Committee shall provide recommendations of a Bail Schedule to the Chief Judge for consideration prior to January 31, 2024.


CSKT Laws Codified, § 2-2-605(4) provides that the Chief Judge of the Tribal Court shall replace any existing bail schedule with a revised bail schedule by January 31 of each year.

Upon consideration of the Committee's recommendations, the Chief Judge shall then issue an updated Bail Schedule by January 31, 2024.

In the interim, the Court shall continue to operate under the Bail Schedule (attached to this Order) that was in effect prior to September 28, 2023.
